Each vendor will be mailed (4) arm bands along with a confirmation letter containing an assigned space number to be presented at the gate.

Move In: Vendors may move in Friday between the hours of 2 pm and 8 pm. There will be paid off duty law enforcement on site all night providing security. Or you may move in on Saturday morning between the hours of 7:00am & 8:30am. Vendors vehicles must be out of the vendor area by 9:00 am.

PLEASE NOTE THIS IS AN OUTDOOR LAKESIDE EVENT. You are welcome to set-up a tent or covering provided it does not exceed your area limits. You may have a "QUIET" generator, but if your generator is loud or disruptive you will be asked to turn it off. All vendor vehicles must be out of the vendor area by 8:30am on Saturday morning. This is a rain or shine event, **NO RAIN DATE OR REFUNDS WILL BE GIVEN.**
